SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Irvington UFSD engaged with a diverse and representative set of applicable stakeholders in developing a plan for ARP funds. Administration and Instructional Leader meetings allowed District leadership and staff to discuss the educational and infrastructure needs of the District and how to best allocate the ARP funds to address these needs. The Reopening Committee, consisting of a wide range of stakeholders including district staff, representatives from the parent teacher organizations and Irvington Education Foundation, parents, students, and local businesses, provided input on how to use the funds for safe in-person learning. Additionally, multiple Board of Education discussions with public comments permitted all district stakeholders to provide feedback on the plan and its implementation in both verbal and/or written forms of communication.

The District will continue to utilize community presentations at Board of Education meetings to update the community at-large on how the use of ARP funds are planned. Also, to inform program development, continue to identify areas of need, and to solicit experiential feedback, parent and teacher surveys will be periodically conducted. These surveys will be reviewed by the Administrative Counsel during monthly meetings to guide the implementation of the plan. Our Instructional Leaders committee, consisting of administrators, Department Chairs, team leaders, and instructional coaches meet monthly and will contribute to tailoring programs to address the needs of the District, such as Social and Emotional Learning initiatives. The NYU Lead Learner Committee consists administrators, Board of Education members, teachers, social worker, and parents. This group will help guide the District's the Diversity, Equity, and Inclusion initiative. All of these stakeholders will be instrumental in developing and implementing these

A portion of the ARP ESSER dollars will be used to purchase portable air purifiers to be installed in all district buildings in locations where transmission risk is greatest due to the activity of the space. These purifiers will reduce airborne pathogens and improve indoor air quality for all staff and students. Funds will also be used to purchase touchless faucets to reduce the risk of virus transmission at high touch areas. Security cameras will be purchased and installed to increase student and staff safety throughout the buildings through monitoring of high traffic as well as hidden areas. Security Cameras can also aid in contract tracing as it can verify the proximity of individuals to any potential positive cases.

The district will review student attendance and academic progress data, using tools such as Aims Web and other formative/summative assessments to identify student needs. Principals will continue to meet with their multi-tiered system of supports (MTSS), department, and grade level teams to also evaluate students progress. The PPS office will closely monitor students with disabilities and referrals made to special education to further identify students needs for students with disabilities and English learners.

5. In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.

Supplemental Instruction programs and new student enrichment programs, including after school, will be designed and developed to address the academic impact of lost instructional time, which will include low income students, students with disabilities, racial and ethnic minorities, and English learners. The design of these programs will be dependent on the review of data and thus the specific details of such programs are in the beginning stages of development.

The focus of these programs will be on strengthening the literacy and mathematics skills of our struggling students. We anticipate that students will be given opportunities to build upon their foundational skills through small group and 1:1 support. Additionally, there will be a focus on social-emotional learning. The specific design of our programs will surface once our data analysis and surveys of student/staff availability times are completed.

- -Social and Emotional Learning program support and development to allow the district to provide mental health services and support to students as they start the new year during the pandemic.
- -Update the District's Strategic Plan to add procedures and systems to improve the preparedness and response efforts of Irvington and other valuable lessons learned during the pandemic. This includes surveying all stakeholders for their input in developing the strategic plan.

- -Security cameras will be purchased and installed to increase student and staff safety throughout the buildings through monitoring of high traffic as well as hidden areas. Security Cameras can also aid in contract tracing as it can verify the proximity of individuals to any potential positive cases.
