WELCOME TO THE BOARD MEETING

The Irvington Board of Education welcomes you. School board meetings are meetings of the board of education that are required to take place in public; however, they are not actually meetings of the public. Rather, they are business meetings held to conduct board business. Thank you for taking the time to attend a Board meeting and participate in the educational affairs of our District.

AT THE MEETING

The Board of Education, the official policy-making body of the Irvington Union Free School District, consists of seven members: residents elected at large by District voters to three-year, unpaid terms of office. The Board President, elected at an annual July organizational meeting, presides at all Board Meetings.

Regularly joining Board members are the Superintendent of Schools, the Assistant Superintendent for Business, the Assistant Superintendent for Curriculum, Instruction, and Assessment and the District Clerk. Others may be invited to sit with or address the Board while making a presentation, providing information or during a work session.

Meeting agendas and other relevant materials will be available for you to follow the evening's planned topics and business. A QR code will also be available to view the agenda and materials on your phone. Additionally, meeting agendas, presentations, or other board information may be accessed online by going to the District's website, www.irvingtonschools.org, and accessing Boarddocs. All official business is enacted in public session. However, an executive session may be held before, during, or after a public meeting to discuss matters involving personnel, litigation, negotiations, or other matters as allowed under state education law.

PUBLIC PARTICIPATION

Each business meeting provides two opportunities when District residents may comment to the Board. The first, “Public Comments on Agenda Items” is the opportunity for public discussion of the agenda items planned for the day. The second period is one for general comments.

If you plan to comment during the meeting:

- Please sign in with the District Clerk
- Please use the microphone, state your name and if you are a resident for the record
- Participants are asked to keep their comments to 3 minutes or less.
- Comment period will last no more than 30 minutes.
- All comments are to be directed to the BOE President.
- Comments and questions will be acknowledged, but will not be answered in session
