## **MSS Health Office Requirements 2022-2023 School Year**

RE: New York State Mandated Health Regulations

**VACCINE INFORMATION:** All students must have up to date vaccines to attend school.

DTaP: 5 or 4 doses, if 4<sup>th</sup> dose given after 4 yrs. of age or older; or 3 doses if 7 yrs. or older and series started at 1 yr. or older.

Polio: 4 or 3 doses, if 3<sup>rd</sup> dose given after 4 yrs. of age or older

MMR: 2 doses

Hepatitis B: 3 doses

Varicella: 2 doses

Please take the time to review your child's immunization record with their healthcare provider to ensure your child has the required vaccinations for their age and grade in school.

**Exclusion from school will result if the above requirements are not met.**

**Requirements for all 5th Graders and all New Students entering the district:** a current physical exam performed by an MD, DO, PA, or NP is acceptable and must be documented on the NYS required physical exam form. (Click the link to access.) The physical exam must be dated no more than 12 months prior to the start of the school year. The exam, and a copy of the immunization record must both be submitted for entrance into school. A dental health certificate is requested.

If applicable, please provide the nurse with a current physical for your child. Submit the completed form along with a current immunization record to the health office by the start of school. **Administration of Medication in School:** This form must be completed each school year for all medications (Over the Counter: OTC and Prescription) and signed by both a parent/guardian and healthcare provider (MD, DO, NP, PA) before medication may be given to your child. All medications must be provided in the original labeled containers and kept in the health office. All medication must be brought to the health office by an adult.

**Food Allergy and Anaphylaxis Emergency Care Plan:** Students with severe allergies must have a current and completed Anaphylaxis Emergency Care form on file in the health office. Please complete and return the form to the health office.

**Asthma Action Plan:** Students with Asthma that require medication during school must have both a completed asthma action plan and a medication authorization form on file in the health office.

**The Health Office Emergency Form:** This form provides valuable information in the event the school nurse needs to reach a Parent/Guardian regarding a health matter during the school year.
