A culture that acknowledges and respects individual differences and provides for varied opportunities for teacher and student learning and innovation.



Project Timeline - Leading to Community Vote

May - June

- Held committee meetings to define scope of work and get feedback from a cross- section of the community; May 2, May 9, May 21, June 6
- July September
 - Preliminary concept sketches based on committee work
 - Presentation to BOE B&G Committee
- September November 15
 - Review cost estimates for scope of work minimum 3 weeks
 - Review estimates with B&G committee and prioritize projects
 - Determine inclusion and project budget Finalize scope of work and make recommendaton to full Board
 - Community Forum
 - BOE determines final scope of work and referendum amount

Project Timeline - Leading to Community Vote

November 15, 2018 – March 12, 2019

- SEQRA process "Type 1", "Type 2" or "Unlisted"
- BOE resolution to declare lead agency February 12
- Potential comment period for Authorities Having Jurisdiction February 12 through March 12
- Bond counsel prepares all necessary resolutions
- March May 2019
 - BOE adopts resolution by mid-March calling for Bond Referendum after May 1
 - SEQRA Determinations adopted by BOE
 - Publish Notice of Bond Referendum in Newspaper March (need 45 days)
 - Public Information Sessions
 - Publish Required Newsletter for voter information

May 2019

• Possible community vote on Bond Referendum

Project Timeline - Leading to Community Vote

Why the change in proposed vote date?

More time is needed to:

- Gather accurate information to make informed decisions
- Allow time for community feedback
- SEQRA process
- Allow enough time to create Board consensus

Date major construction work can begin will be largely unchanged

Project Timeline (After the Successful Vote)

June 2019 - December 2019*

- H2M prepares detailed construction documents
- January 2020 October 2020*
 - State Education Department (SED) reviews, approves and issues building permits
- November 2020 March 2021*
 - Bidding and Awards

June 2021

• Large-scale construction starts

Some smaller projects might be able to begin in Summer 2019 and 2020.

- Less involved construction documents and/or SED review required
- Fast track process for SED if available

*Some more in-depth projects will require a longer period for construction documents and thus will push back these dates. However, the period for bidding & permitting is fairly long and the target of June 2021 should still be attainable. Alternatively, a final construction phase of June 2022 may be targeted. 8

Safety & Security Needs

- Add walls to enclose walkways and secure open buildings -Campus, MSS
- New vestibule entry points for schools
- Install interior and exterior cameras
- Swipe card door entry system
- Replace interior doors and door hardware for ADA compliance -Dows, MSS

Safety & Security Needs - Continued

- Improve lighting with more fixtures
- Install radiator covers on exposed radiator piping MSS
- Remove and seal coal chute MSS
- Replace exterior shade panels HS
- Safety bollards
- Hallway control to limit access off hours
- Safety film on windows

Academic/Student/Staff Needs

- Create Flexible Learning Spaces all schools
- Add functioning kitchen at MSS
- Outdoor bathrooms for Field use/Athletic program Dows, Campus
- Classroom Casework primarily HS/MS, old wing Dows; Music/Art room renovations
- New phone system VOIP and improved/new PA system (also safety need)
- Enhance upper quad area in Campus to facilitate learning
- Replace bleachers; Replace field tower to a better location with more storage or combine with bleachers

- Academic/Student/Staff Needs Continued
- Renovate Girls' Bathroom at HS
- Redesign/Improve Cafeterias support HS schedule needs and create learning/collaborative spaces
- Redesign HS Atrium into student collaborative space
- Redesign Media Center to create collaborative spaces and quiet study spaces
- Relocate Faculty Lounge
- Improve locker rooms at Maher Gym
- Theater needs carpet, sound equipment cabinet

Storage & Protection of Resources Needs

- Maintenance building/space to house district vehicles, equipment, plows and perform repairs
- Storage shed for athletic equipment (combine with press box?)
- Classroom casework (art & music rooms)

Facility Maintenance/Infrastructure Needs

- Roofing
 - New roof above library wing Dows
 - Roof panel repair Campus
 - Gutters
- Replacement & installation of several exterior and stairwell fire doors -Campus, TG, MSS
- Replace Meszaros Field/Oley Track fencing
- Change ceiling grid and tiles TG locker rooms
- Exterior wall repair/shade panels HS
- Replace waste lines MSS
- Floor abatements Dows gym, MSS classrooms
- Move electrical service underground at East Field

Energy Efficiency/HVAC Needs

- Replace boiler Dows
- Replace classroom univents HS
- Add standalone AC unit for CPR
- Upgrade interior and exterior lighting with LED
- Window replacements
- Air conditioning for classrooms
- Replace Building Maintenance System controls
- Solar panels & other efficiency opportunities
- Generators for backup during storms/power outages

Paving/Sidewalks Needs

- Pave parking lots, roadways and play areas Dows, MSS, Campus
- Increase parking District-wide
- Gate to staff parking lots and more visitor parking
- Improve traffic flow
- Sidewalk/concrete repair

Next Steps

- Architect created concept sketches based on committee work
 complete
- Architect adding detail to concept sketches for cost estimating – ongoing
- Construction Manager to add costs to scope of work list pending
- Prioritize scope with consideration of cost info & CPPC priority
- Make recommendation to Board for final scope of work for community vote
- Host community forums TBD Fall 2018
- Board to determine final scope of work for SEQRA process
