
### **Overview**

Positive school climate is an essential component of successful and effective schools. It is defined as shared beliefs, values, and attitudes that shape interactions between students, teachers, and administrators, while setting the parameters of acceptable behavior and norms for the school.

The Irvington Union Free School District (UFSD) School Quality and Climate Surveys asked parents, community members, staff members, and students in grades 6-12 for feedback on school climate, district leaders, and district initiatives. Results will be used to inform decisions at the campus and district levels.

K12 *Insight* partnered with district team members to develop the surveys, which addressed the following topics:

- Learning experiences
- Support for students
- School leadership
- Family involvement
- Safety and behavior
- Communication
- Board of education
- District Leadership Team
- Strategic objectives



### **Details of the Study and Understanding the Results**

The surveys for parents, community members, and staff members were open from April 12 to May 9. The survey for students was open from April 22 to May 9.

Email invitations with unique survey links were sent to parents, community members, staff members, and students in grades 6-12. Parents and community members could also participate via a public link on the district's website. Parents with children attending more than one district school were able to take the survey again. Reminders were sent on April 18, 23, 26, and 30 and May 2 and 7.

The survey was translated into Spanish. Paper surveys were available on request.

Pre-survey communications included emails, a phone script, a district website description, and social media posts.

This report summarizes survey results and and breaks them down by participant group. Results do not reflect random sampling; therefore, they should not be generalized to all Irvington UFSD parents, community members, staff members, and students in grades 6-12. Rather, results reflect only the perceptions and opinions of survey participants. School-level reports are also included in this project.

Findings for each item in the report exclude participants who did not answer. In charts and graphs, data labels less than 5 percent are not shown. Percentages may not total 100 due to rounding.





## **Overall School Quality**


How would you rate the overall quality of this school?






# **Overall School Quality**

How would you rate the overall quality of this school?









How would you rate the overall quality of this school?






### **Dimension Scores: Comparison by Respondent Type**






### **Learning Experiences: Comparison by Respondent Type**


### Support for Students: Comparison by Respondent Type












### Safety and Behavior: Comparison by Respondent Type






## **Board of Education: Comparison by Respondent Type**




How much information does the school board provide? (N=639)


How much information do you receive from the school board? (N=156)





# **Amount of Information: District Leadership**


How much information do you receive from district leadership? (N=629)






# **Amount of Information: District Leadership**






### **Net Promoter Score** — **District**

How likely are you to recommend Irvington UFSD to a friend or colleague?









### **Net Promoter Score — School**

How likely are you to recommend this school to a friend or colleague?




Notes: Participants were asked how likely they were to recommend their child(ren)'s school(s) to a friend or colleague on a scale of zero to 10, with zero being Not at All Likely and 10 being Extremely Likely. The scores are clustered into promoters, passives, and detractors based on the rating. The net promoter score is calculated by subtracting the percentage of detractors from the percentage of promoters. Only parents of current students were given this question.

How likely are you to recommend Irvington UFSD to a friend or colleague?







How likely are you to recommend this school to a friend or colleague?








### **Key Insights**

- 86% of parents and 77% of students who took the survey rated their school as excellent or good, which is a slight decline from last school year for both participant groups. However, 92% of participating staff members rated their school as excellent or good, which is a 7 percentage-point increase from last school year. The school and district net promoter scores for parents and staff members followed a similar trend, with scores declining for parents but increasing for staff members.
- 81% of participating staff members agreed or strongly agreed that students are shown how lessons relate to life outside of school compared with 33% of participating students. This is a 5 percentage-point increase for staff members and a 3 percentage-point decrease for students from last school year. It may be beneficial to explore why this perception gap is expanding.
- 92% of participating staff members agreed or strongly agreed that students and staff members treat each other with respect compared with 77% of participating parents and 73% of participating students. Agreement on this item has declined by 3 percentage points for parents but has increased by 2 percentage points for staff members and 8 percentage points for students from last school year.
- The family involvement dimension had the highest percentage of agree and strongly agree responses from participating parents (81%) and participating students (77%). Engaged parents have a positive impact on student achievement.
- Though 92% of participating staff members agreed or strongly agreed that the school has high learning standards for all students, 24% of participating parents disagreed or strongly disagreed that students are appropriate challenged by their schoolwork.
