Reopening Updates



Superintendent's Conference Days

Three Superintendent's Conference Days were held, September 2-4, to prepare for the reopening of school. During these days, professional learning/training was offered in the following areas:

- Health and safety
- Social and emotional needs/learning
- New school/District protocols and procedures
- Technology
- Instructional design to support hybrid and distance learning
- Equity, diversity and inclusion



Chromebook Distribution

The District will ensure equity and access to learning for all students by providing each student with a Chromebook and internet access, where needed.


- Due to manufacturer's' production delay, the IUFSD implemented a modified distribution plan prioritizing the following:
 - Students without devices at home for school use
 - Students enrolled in 100% distance learning
 - IMS students (due to 1:1 program)
 - Teachers and aides to deliver instruction
- 861 Chromebooks distributed to date
- Once all Chromebooks are received (ETA 2 weeks), another distribution will be facilitated



100% Distance Learning Option

100% distance learning enrollment:

- 1,725 District enrollment
- 166 students District-wide
- 9.6%





Daily Health Screening Requirements

Each student and staff member will be required to complete a daily health self-screening questionnaire prior to leaving for school/work.

- App is available for download in the Apple App Store and Google play
- Web-based application posted on the website
- Students for whom the screening was not completed will not be permitted to attend class until health is verified
 - Repeat occurrences will result in parents having to pick student up from school




Screening Flow Chart for Symptomatic Students/Staff at School

Interscholastic Athletics

IUFSD will follow all guidance issued by NYSDOH, NYSPHSAA & Section 1

- High School Cross Country, Field Hockey, Soccer, and Girl's Tennis are permitted to begin Tuesday,
 September 29th
 - No open workouts or practices are authorized prior to September 29th
 - Section 1 guidance on games forthcoming
- High risk fall sports (Football & Volleyball) and their ability to practice is being reviewed by Section 1
 - No high risk practices/games until Governor gives consent
- Section 1 Modified Committee will meet to evaluate the status of modified fall sports
- Season schedules to be modified per Section 1 guidance
- Medical Clearance for participation
 - All students must have previously approved health examination for school attendance from the 2018-2019 or 2019-2020 school years
 - o Parental permission and updated health history form on FamilyID within 30 days of sport start date.
- Specific Athletics Department health & safety protocols will be implemented
- Training to be provided to all coaches by the Athletic Director, Athletic Trainer and School Nurse
- Specific details to be sent to parents and student-athletes by the Athletics Department



Transportation

- Due to the need to ensure that bus routes are aligned with parent survey data and are as efficient as possible, in-District bus route and bus stop details will not be available until the week of September 14th.
- Out-of-District bus route and bus stop details are available now in the Transportation Portal



- Remote meals available beginning today preorder only
 - <u>Lunch order for remote instruction days</u>
- Pre-order system will be used for Elementary meals beginning September 21st.
- Meals will now be at no cost to all families. This includes meals only, not snacks, additional beverages or ala carte items.



Budget: Reopening Costs to Date

The reopening of school has resulted in numerous unbudgeted expenses. Some of the expenses will be funded through reallocation or reprioritization of the budget, while others will result in budget adjustments. These costs are evolving based on need and environmental factors.

Items Needed	Cost
K-1 costs (monitors, buses, custodial time)	\$61,000
PPE (masks, gloves, face shields, plastic barriers, desk coverings, wipes, hand sanitizer, thermometers)	\$95,000
Monitors to cover teachers working remotely	\$186,700
Other Covid Supplies (signage, filters, radios, hand washing stations)	\$19,500
Technology (less budget reallocations)	\$64,785
Total	\$426,985
